

RESOLUTION NO. 19-03-06

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, APPOINTING INDIVIDUALS TO SERVE AS ELECTION POLLWORKERS: CLERKS, ADVISORS, COMPUTER LAPTOP OPERATORS, AND INSPECTORS FOR THE RUNOFF ELECTION FOR THE OFFICE OF COMMISSIONER FOR SEAT C OF THE TOWN OF LAKE PARK; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park will conduct a Runoff election on Tuesday, March 28, 2006 to elect a Commissioner for Seat C for the Town of Lake Park, Florida; and

vote, the vote was as follows:




