

RESOLUTION NO. 38-07-06

A RESOLUTION OF THE TOWN COMMISSION OF LAKE PARK, FLORIDA, CORRECTING THE SALARY RANGE FOR THE POSITION OF LIBRARIAN II; AMENDING THE CLASSIFICATION AND PAY PLAN TO REFLECT SUCH CORRECTION; PROVIDING FOR THE PUBLICATION OF AN UPDATED CLASSIFICATION AND PAY PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park is a duly constituted municipality organized and existing under the laws of the State of Florida and Chapter 166, Fla. Stat; and

WHEREAS, in 2005 the Town Commission of the Town of Lake Park approved the revised salary ranges for certain classifications of the Lake Park Public Library; and

WHEREAS, as a result of such revision it has been found that the salary ranges for the Librarian I and Librarian II positions are identical; and

WHEREAS, it is necessary to correct the salary range for the Librarian II position to \$35,000.00 to \$46,000.00 per annum; and

WHEREAS, the Town maintains a position classification plan known as the Classification and Pay Plan; and

WHEREAS, the Classification and Pay Plan is based upon similarity of duties performed and responsibilities assumed, so that the same qualifications are reasonably required for the same schedule of pay, and are equally applied to all classifications in the same class; and

WHEREAS, it is necessary to amend the Classification and Pay Plan to reflect the correction of the salary range for the Library II position.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA:

Section 1: The foregoing recitals are incorporated herein as true and correct and are hereby made a specific part of this Resolution.

Section 2. The Classification and Pay Plan is hereby amended to correct the salary range for the Librarian II position to \$35,000.00 to \$46,000.00 per annum.

The foregoing Resolution was offered by Commissioner Osterman who moved its adoption. The motion was seconded by Commissioner Balius, and upon being put to a roll call vote, the vote was as follows:




