

RESOLUTION NO. 44-06-07

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, AUTHORIZING THE IMPLEMENTATION OF A FREQUENT SUMMER RAMP PASS PROGRAM AT THE LAKE PARK HARBOR MARINA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park (“Town”) is a municipal corporation of the State of Florida with such power and authority as has been conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town of Lake Park owns and operates a municipal marina; and

WHEREAS, Town staff has recommend to the Town Commission that it adopt a Frequent Summer Ramp Pass Program providing for a 20% discount on ramp charges at the Lake Park Harbor Marina for the period of June 7, 2007 through September 7, 2007; and every year thereafter; and

WHEREAS, the Town Commission has considered the recommendations of Town staff and has determined that it would be in the best interests of the Town to adopt the Summer Ramp Pass Program for use at the Marina.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK:

Section 1. The Whereas clauses are incorporated herein as true and correct and are incorporated herein.

Section 2. The Town Commission hereby approves a Frequent Summer Ramp Pass Program which would provide a 20% discount on ramp charges allowing individuals to purchase six ramp passes for the price of five, for the period of June 7 through September 7, 2007.

Section 3. The Frequent Summer Ramp Pass Program may be implemented annually unless the Commission takes action to discontinue it.

Section 4. This Resolution shall take affect upon adoption.

The foregoing Resolution was offered by Commissioner Balius, who moved its adoption. The motion was seconded by Commissioner Osterman, and upon being put to a roll call vote, the vote was as follows:
