

RESOLUTION NO. 54-08-07

A RESOLUTION BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA AUTHORIZING THE EXPENDITURE OF \$26,840.00 FROM THE TOWN'S LANDSCAPING SPECIAL ASSESSMENT FUND DOLLARS TO PAY FOR THE COSTS OF LANDSCAPING THE RAISED PLANTERS ALONG THE EASTERN BOUNDARY OF LAKE SHORE PARK IN THE TOWN OF LAKE PARK; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Park, Florida ("Town") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town Commission has such powers and authority as conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town Commission of the Town of Lake Park, Florida has determined that is in the best interest of the public health, safety and general welfare to utilize Landscaping Special Assessment Fund Dollars in the amount of Twenty Six Thousand and Eight Hundred and Forty Dollars (\$26,840.00) to pay for the costs to landscape the raised planters along the Eastern Boundary of Lake Shore Park within the Town; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA:

Section 1. The foregoing recitals are incorporated herein as true and correct findings of the Town Commission.

Section 2. The Town Commission hereby authorizes the use of the remaining Landscaping Special Assessment funds in the amount of Twenty Six Thousand and Eight Hundred and Forty Dollars (\$26,840.00) to pay for the completion of the landscaping of the raised planters along the Eastern Boundary of Lake Shore Park in the Town.

Section 3. This Resolution shall be effective upon adoption.

The foregoing Resolution was offered by Commissioner Balius, who moved its adoption. The motion was seconded by Commissioner Osterman, and upon being put to a roll call vote, the vote was as follows:


