Bids received after this time will be returned unopened. Bids submitted will be opened publicly and read aloud at this time.

Bidders may obtain complete sets of Bidding Documents from the Town Clerk, Town of Lake Park, 535 Park Avenue, Lake Park, FL 33403 upon payment of \$40.00 per set, check payable to the Town of Lake Park. Payment amount is non-refundable. Partial sets of Bidding Documents will not be available.

If bidding documents are to be mailed an additional separate payment of \$20.00 for each set, to cover shipping and handling, shall be made payable to the Town of Lake Park. Payment in full must be received by the Town prior to the issuance of the Bid Documents.

Bidding Documents may be examined at the Town of Lake Park Town Hall at the above referenced address.

Each proposal must be submitted on the Proposal forms included in the Contract Documents and must be accompanied by a cashier's or bank check on a solvent bank, in compliance with Section 255.051, Florida Statutes, made payable to the Town of Lake Park, in an amount not less than five percent (5%) of the total bid, or a bid bond of like amount, on the form set forth in the Contract Documents, as a guarantee that, if the

Proposal is accepted, the Bidder will execute and fill in the proposed Contract and furnish a Payment Bond and a 100% Performance Bond within ten (10) days after Notice of Award of Contract.

The Owner reserves the right to reject any or all Bids with or without cause, to waive technical errors and informalities, and to accept the Bid which best serves the interest of the Owner.
