I want to notify you of an upcoming change impacting drivers. The Florida Department of Highway Safety and Motor Vehicles closes its West Palm Beach office on June 26. The office closing is required because the Florida Legislature transferred the issuing of driver licenses to Constitutional Tax Collectors.

- Buy hunting and fishing licenses
- Address changes and replacements for REAL ID compliant licenses

### Mail your payments:

- Send before your deadline
- Allow time for slow postal delivery
- Follow all payment instructions

### IS THERE RELIEF IN SIGHT?

Our new Central Palm Beach County Service Center is scheduled to open in November 2015.

The Lantana and Lake Worth Service Centers will close for 10 days before the new office opens. The closing is needed to move, install and test equipment.
